Subject : Filling up of 9 posts of Despatch Rider in the level 2 of pay matrix, in the Bureau of Civil Aviation Security on deputation.

Nine posts of Despatch Rider (General Central Service Group 'C' Non-Gazetted, Non-Ministerial) in the **level 2 of pay matrix** [Pay Band 1 (Rs. 5200-20,200/-) with Grade Pay of Rs.1900/-] in the Bureau of Civil Aviation Security, under Ministry of Civil Aviation, Government of India is to be filled up. (The exact number of vacancies may increase or decrease at the time of selection). The posts are to be filled up on deputation basis from amongst Police Constables from Central Police Organisations or Delhi Police or State Government Police possessing valid driving license for Motor cycle or three wheeler scooter.

2. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years.

3. The maximum age limit for appointment on deputation basis shall not be exceeding 52 years as on the closing date of receipt of the application.

4. The candidates selected for deputation to the post of Despatch Rider will be governed by the terms and conditions of deputation laid down in the Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel and Training OM No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 as applicable and amended from time to time.

5. The candidates will have option to either draw pay in the scale of pay applicable to them in their parent organization plus deputation (duty) allowance or have their pay fixed in the scale of pay applicable to deputation post.

6. The Bio-data, in the prescribed format (in duplicate), of suitable candidates may be forwarded along with the following documents, within 60 days from the date of publication of this circular in the 'Employment News'.

7. List of essential documents to be attached with the Bio-data:-

- i) Vigilance Clearance Certificate;
- ii) Integrity Certificate;
- iii) List of penalties (Major/Minor) imposed, if any, during the last 10 years;
- iv) APARs/ACRs for the last five years (It may be noted that the photostat copies of ACRs/ PARs should be attested by an official not below the rank of Under Secretary to the Government of India or equivalent on each page).

Important Note: Incomplete applications and applications forwarded without the complete set of essential documents listed above shall be rejected.

8. Candidates who apply for the post will not be allowed to withdraw their candidatures subsequently.
