In case of failure to exercise his option within the prescribed time limit, the pay will be fixed as per rules in force by the Estt.II Section, O/o the IGP, Puducherry.

3. There will not be any further fixation on functional promotion in respect of his cadre following the financial up-gradation.

4. In case of refusal to accept regular promotion subsequently the employee concerned shall be reverted from the higher scale granted under Assured Career Progression Scheme (ACP)

5. Necessary approval of the Chief Secretary has been obtained in this regard.
