Councils, Principals, Colleges, Kerala and other. Copy of the judgment of the Hon'ble Supreme Court of the India is available on www.courtncic.nic.in/courtncicse.asp.

2. As advised in the previous year, you are kindly requested to direct all the Police Authorities at the district and police station level to comply with the judgment of the Hon'ble Supreme Court of India by way of :

- participating in anti-ragging committee of institutions and district level anti-ragging committee,
- registering private commercially managed lodges or hostel outside campus,
- keeping vigil on incident of ragging, taking immediate action on receiving distress message from victim of ragging
- directing SHO/SP within whose jurisdiction a particular education institution fails that no ragging takes place on the campus of the concerned educational institution
- to effectively deal with incidents of ragging, if any such incidents take place.

This will build confidence and encourage people to report incidences of ragging without fear.

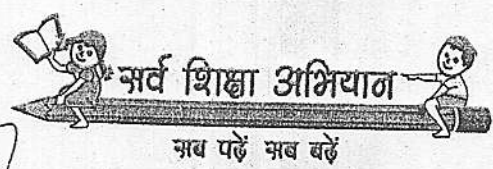
