Kindly refer to my D.O. letter No.16-8/2015-U.5 dated 19th August, 2015 regarding compliance in accordance with the order of the Hon'ble Supreme Court dated 8th May, 2009 (in Civil Appeal No.887 of 2009) in the matter of University of Kerala Vs. 2. In this regard, you are kindly requested to direct the concerned authorities at the District level to comply with the judgement of the Hon'ble Supreme Court of India by way of:

- participating in anti-ragging Committees of educational institutions and district level anti-ragging committee
- registering private and commercially managed lodges or hostel outside College/University campus
- keeping vigil on incidents of ragging, taking immediate action on receiving distress messages/calls from victim of ragging
- directing SHOs/SPs to ensure that no ragging takes place in the campus of the concerned educational institutions which fall within their jurisdiction
- effectively dealing with incidents of ragging, if any such incidents take place.

The above measures will build confidence and encourage students and parents to report incidences of ragging without fear.
