2. In order to enforce the arrangement, the assistance of 64 IRBn are required during the above duty. It is requested that approval may please be given to obtain the adequate IRBn Police personnel strength for the above duty so as to carry out the scheme.

**POLICE ARRANGEMENTS IN CONNECTION WITH WEEK-END DUTY  
DEPLOYMENT**

**INTRODUCTION:**

During the week-end adequate law and order arrangements are required to be provided to prevent obstruction of traffic and incidence of crimes such as theft, snatching, robbery, etc in market places. The following arrangements are, therefore made w.e.f 20.08.2016.

**TEMPORARY CHECK-POSTS**

To apprehend criminals committing crimes, the entire Boulevard area is cordoned off by keeping mobile barricades and setting up 18 temporary check-posts manned by 1 local constable and 2 IRBn each as follows:

- (i). On Dr. Ambedkar Salai near Uppanar Bridge at (Odiansalai PS limits).
- (ii). On Subbaia Salai near Pullukadai junction (Odiansalai PS limits).
- (iii). On M.M. Salai near Newtowne Theatre (Odiansalai PS limits).
- (iv). On Anna Salai at the junction of Pothys (Odiansalai PS limits).
- (v). On Anna Salai at the junction of Govindasalai Lane (GB PS limits).
- (vi). On Anna Salai at the junction of Thirumudi Nagar (GB PS limits).
- (vii). On Kamrajalar Salai at the junction of Kumaragurupallam road (GB PS limits).
- (viii). On Anna Salai near patchamuthu Mariamman Temple (GB PS limits).
- (ix). On 45 feet Road near Andhra Maha Sabha (GB PS limits).
- (x). On Kumaragurupallam near D.A.T. (GB PS limits).
- (xi). On S.V.Patel Salai near Anandha Inn (Muthialpet PS limits).
- (xii). On M.G. Road at the junction of Chinnaiyapuram (Muthialpet PS limits).
- (xiii). On S.V. Patel Salai at the junction of Pazhani Kiramani Street (Muthialpet PS limits).
- (xiv). On S.V. Patel Salai at the junction of Akkasamy Madam Street (Muthialpet PS limits).
- (xv). On S.V. Patel Salai at the junction of Dr. Ambedkar Street (Muthialpet PS limit).
- (xvi). On S.V. Patel Salai at the junction of Kaali Amman Koil Street (Muthialpet PS limits).
- (xvii). On S.V. Patel Salai at the junction of Francois Martin Street (Muthialpet PS limits).
- (xviii). On S.V. Patel Salai near Old Distillery (Muthialpet PS limits).

In order to maintain better Police vigil, the market area is divided into four zones each under one SG(ASI) , 1 PC and 2 IRBn PCs as follows:

- (i). Beat No. I-covers the area in between J.N. Street, Anna Salai, Aravindar Street and M.G. Road.
- (ii). Beat No. II-covers the area in between J.N. Street, M.G. Road, Aravindar Street and H.M. Kassim Salai (Ambour Salai).
- (iii). Beat No. III-covers the areas in between of J.N. Street, Anna Salai, Petti Canal Street and M.G. Raod.
- (iv). Beat No. IV- covers the areas in between J.N. Street, M.G. Road, Petti Canal and H.M. Kassim Salai (Ambour Salai).

Also In order to maintain better Police vigil, in the **Beach road** additionally 10 IRBn police personnel to be provided to Grand Bazaar and Odiansalai each. SHO Grand Bazaar and Odiansalai shall deploy the 20 IRBn in the Beach road to perform **foot patrolling** along with an Officer.

#### **GENERAL INSTRUCTIONS:**

While dealing with public, the Police personnel entrusted with the above duties shall be utmost polite and courteous. They shall be however be very firm against rowdies and anti social elements. The public shall be advised to be careful about their children and belongings. Any mishap must be contained at the spot and there must not be any panic reaction on the part of the Police personnel on duty.

#### **BARRICADING ARRANGEMENTS:**

SP(Traffic) is requested to make necessary barricading arrangements at the temporary check post .

#### **SOURCE OF SUPPLY**

CMT IRBn /DC IRBn is requested to provide 66 IRBn along with heavy vehicle for every Saturday and Sunday.

#### **TIME OF DUTY:**

From 08.00 hrs to 22.00 hrs (in two shifts on every Saturday, Sunday and Public holidays)

#### **BRIEFING:**

SHO Grand Bazaar PS, SHO Odiansalai PS and CI Muthialpet shall brief the Police personnel before they are deployed for week-end duty.

#### **NOTE:**

STF personnel shall assist SHO Grand Bazaar PS, SHO Odiansalai PS and CI Muthialpet for the above arrangements.

SHOs of Grand Bazaar PS, Muthialpet PS and Odiansalai PS shall prepare and submit week-end reports to the undersigned
