SUB : ATROCITIES ON SCs- SEEKING PROTECTION DURING THE FORTHCOMING ASSEMBLY ELECTION-2016..

The representation 25.2.2016 received from Mr. S. Gnanamoorthy, Puducherry State President, Republican Party of India (A) is self explanatory.

1. It is reported that that the dalits/SCs living in dalit villages such as reserve constituencies such as Behur SC reserve Assembly constituency, Emblam, Nettapakkam, Thirubavani in Puducherry Union Territory and Nedungadu, Karaikkal Region of Puducherry UT are under frequent attack and atrocities being committed by the caste-Hindus. This is more so during election times in order to prevent the dalits from exercising their franchise freely without any fear. As they are voiceless they become victim of money power and muscle power of ruling and other parties.
2. The present government under the Chief Ministership Shri Rangasamy of All India N R Congress Party is no exception in this regard. The NR Congress party is also field candidates. Such candidates of the said Party are likely to cause danger to dalit candidates and dalit voters in view of misusing police force due to the support of present ruling party.
3. More police protection is called for in the Reserve and General constituencies where candidates of NR Congress Party fields are candidates.
4. SC/ST atrocities cases are not registered in local police stations and the dalit victims are made to run from pillar to post by asking them to go to SC/ST Cell.
5. The ruling government is not allotting free house plots being distributed through Adi Dravida Welfare Department to the needy buy allotting the ruling party candidates and each such family is allotted five plots. The plots are to be distributed from Monday, 29.02.2016. The allotment should take place after proper enquiry only.
