Shri M.V. Rao,

CRPF has been entrusted to provide security to protectees of different threat categories by Ministry of Home Affairs, GOI. These protectees visit different parts of the country but frequency of their tours increase manifold especially during elections.

2. As you are aware that the Assembly Election- 2016 in Puducherry scheduled to be held on 16/5/2016. As per past practice Protectees of CRPF would frequently visit Puducherry for campaigning, election rallies etc. Accordingly, additional 03 teams along with Officers of VIP Security Bns being placed to cover the tour programme of CRPF protectees during election, as requested vide your message No. D.III-VIP/2016-Ops dated 28/1/2016.

3. In this context, it is requested that the following logistical and security arrangements required may be discussed at all meeting with State Administration, Police and Election Officials so that they are in a position to mobilize the same.

- i) **Bullet proof vehicle for Z+ protectee :**  
This may be placed centrally in 2-3 districts of each phase. It would be advisable to keep more number of BP vehicles in Districts/places having airports as protectee are more likely to come there often.
- ii) Each District must have 2-4 road worthy escort vehicles kept reserve/ ready to accompany the protectee for escort (protection duty) by CRPF VIP security teams. It would be advisable to keep more number of vehicles in places having airports due to above reasons.
- iii) Two light vehicles per CRPF VIP Security team is required. There shall be 03 additional teams of VIP Security made available in your ops jurisdiction.

Accommodation @ 1 room for officer, 1 Room for SOs, and 1 dormitory for Jawans for each VIP security team should be made available in Districts where teams are stationed.

A pilot vehicle with local police component and radio set and operator to communicate between the escort vehicle and state police control room should be made available with the Z+ category protectees visiting the Districts.



## 5. Security arrangements :-

- i) Anti Sabotage check to be carried out at all places of visit, halt, helipad etc.
- ii) Deployment to be placed after carrying out Anti-sabotage checks.
- iii) Access control to be enforced at all places of visit, halt etc. No person or any materials to be allowed without prior checking and frisking. Sufficient nos. of HHMD, DFMD to be placed for this purpose.
- iv) Sufficient number of personnel to be deployed for crowd control at public meeting /venue and helipad.
- v) Place of halt must be secured by planned deployment inside and outside the building. All parked vehicles in the close vicinity must be subjected to Anti sabotage checks. Fire hazard precautions must be ensured.
- vi) All staff and personnel deployed in close proximity consisting of driver, security service staff etc must be identified and vouched safe. They must be in possession of Photo I.D cards.
- vii) Hospitals for emergency evacuation must be earmarked. Similarly safe house must be earmarked for operational contingency.
- viii) Contingency routes to be decided before the public meeting.
- ix) Fire tender and fire extinguisher with staff must be available at the helipad.
- x) The area around the rostrum/dais should be kept clear and no unidentified unauthorized/ unchecked person should be allowed.
- xi) All activities at the proposed site of the Protectee for halt/function etc. must be verified and kept under close watch by deploying security personnel.
- xii) Any other security measure found appropriate according to local situation must be kept in mind.
- xiii) Personal as well as physical security must be ensured.

6. The above mentioned measures may please be ensured for error free performance of VIP security duties.
