CIRCULAR/I.D.NOTE

Sub: CVO - Online submission of Immovable Property Returns for the year 2022 (to be submitted in 2023) - Instructions - Issued - Reg.

Ref: 1. Circular/I.D.Note of even number dated 05.12.2022
2. Circular/I.D.Note of even number dated 13.01.2023

Reference is invited to the Circular/I.D.Note first cited wherein detailed instructions were issued for online filing of immovable property returns for the year 2022 to be submitted on or before the due date of January 31st 2023 in respect of Group 'A' and 'B' officers. It was brought to the notice that many officers have forgotten their password already set in last year and needed to reset. Hence, further instructions were issued vide Circular/I.D. Note second cited.

2. On perusal of the online portal, though majority of the officers have uploaded their online IPRs, still considerable number of officers, especially those serving in subordinate offices and rural areas, are yet to upload their IPRs, owing to password issue. It is seen that certain officers have submitted their IPRs but not uploaded the signed copy and thereafter downloaded the acknowledgement. Officers who have uploaded the signed copy and taken the acknowledgement are alone considered as having submitted the online IPRs. It is also brought to the notice that the newly promoted officers from Group 'C' to Group 'B' during the month of December 2022 are also finding difficulty in submitting their IPRs through online.

3. Considering all the above, the timeline for online filing of IPRs for the year 2022, as a one-time measure, is extended upto 15th February 2023. All the Group 'A' and 'B' officers who are yet to file their online IPRs return are instructed to comply the deadline and delay or non-filing of online IPR will not be condoned. **Further, there won't be any issue of show cause notice regarding non-filing of online IPRs and the Disciplinary Authorities will be asked to institute disciplinary proceedings straightaway against those officers which will entail denial of vigilance clearance.**

4. All Heads of Departments are therefore requested to disseminate the contents of this circular to all concerned.
