INVITING TENDER

Sub: Police Department, Puducherry – Calling of Quotations for Repainting and retightening of bolts & nuts, replacement of damaged angles of 100 feet self-supporting tower at Repeater station, Yanam – Reg.

Sealed quotations are invited from experienced and reputed firms for carrying out the maintenance works of a 100 feet Self-Supporting Wireless Telecommunication Tower (repainting, re-tightening of bolts/nuts, replacement of damaged angles and allied works) erected and functioning at Yanam Police Station Complex, Yanam, as detailed below.

Sl. No.	Description of the works	Rate (Including GST)
1.	Scrubbing of rust in the existing tower	
2.	Providing one coating of red-oxide paint and two coatings of synthetic enamel paint of orange and white colour at equal intervals for ensuring proper day and night markings to suit condition of M.O.C (Ministry of Communication)	
3.	Retightening of Non-galvanized M.S bolts & nuts of Non-galvanized M.S angles in the tower	
4.	Replacement of any broken Non-galvanized M.S bolt and nuts Non-galvanized M.S angles/Non-galvanized M.S Chequered Plastic etc. in the tower	
5.	General check-up of fittings such as lighting arrester /Ladder/Plat form/Name Board, warning lamp and earthing arrangements etc., and replacement if necessary.	
6.	Check-up of the existing 6 feet height G.I chain link fencing and its angle post and door with frame locking arrangements at the site of the Tower.	

2. The firm is requested to provide the estimated rate including terms and conditions, additional charges like GST etc., for the above-said work in a 'sealed cover', the subject matter shall be superscribed as "Quotation for the repair of 100 feet self-supporting tower at Repeater Station, Yanam" on the cover and addressed to "The Superintendent of Police (HQ), No.2, Dumas Street, Puducherry – 605 001".


3. The quotation should reach the Office of the Superintendent of Police (HQ), Puducherry of this Department before the due date mentioned below and intimate your acceptance on the following conditions in case the rate(s) quoted by your firm are accepted and work order is placed with you.

4. The Police Department, Puducherry is not responsible for the delay in transit, if the quotations are sent by post. The bids received late, (i.e., after the due date & time prescribed), shall not be accepted and opened for any reason. In case of unforeseen circumstances, the date of opening of the bid will be the next working day or as notified separately.

5. Last date and time of receipt of quotations is 01.02.2026 at 16.00 hours. The quotations will be opened on the same day at 17.00 hours.

6. Only authorized firms/Companies are eligible.

7. No materials will be supplied by this department. The firm/Company is expected to take all precautionary measures in carrying out the work. The department will not hold any responsibility in this regard.
8. The rates once quoted and approved will be final for 120 days from the date of acceptance and no deviation in rates will be allowed.
9. The company may quote their previous experiences in painting/maintenance of such towers and work completion certificates obtained from various departments/companies.
10. The work should be taken up within 2 weeks from the date of receipt of our order.
11. The time limit for completion of work is 30 days only from the date of starting of the work.
12. Warranty of the painting and other works shall be mentioned.
13. Also GST No. and Telephone/Mobile Numbers, etc., shall be mentioned in your quotation clearly.
14. No advance payment should be insisted in the quotations.
