C I R C U L A R

These instructions provide guidance to the Police Officers on the supervision, enforcement and response to the breaches of bail conditions imposed on an accused persons by a court.

Instructions to the Police Officer for Monitoring Bail Conditions

1. **Attendance and Reporting:** Confirm that the accused reports to the concerned police station on the days and at the times specified in the bail order. Maintain an attendance register to monitor compliance.
2. **Verification of Residence:** Ensure that the accused resides at the address mentioned in the bail order. Conduct periodic verification visits and record observations in the station diary.
3. **Other Police Station:** If an accused is released on bail with a condition to appear before a police station of another jurisdiction or region, the concerned police station, Court Police Constable, and SHO shall inform the respondent police station for further proceedings. The respondent police station shall periodically verify and ensure that the accused has complied with the bail conditions.
4. **Restriction on Movement:** Monitor that the accused does not leave the jurisdiction or travel to restricted areas without prior permission of the Court.
5. **Non-Interference with Investigation:** Ensure that the accused does not attempt to contact, influence, threaten, or intimidate prosecution witnesses or tamper with evidence in any manner. Monitor that the accused does not contact with their associates/co-accused.
6. **Victim Protection:** Particular attention shall be given to conditions intended to protect victims.
7. **Law and Order Compliance:** Observe and ensure that the accused does not involve himself/herself in any criminal or unlawful activity during the bail period.
8. **Cooperation with Investigation:** Ensure that the accused cooperates fully with the investigation and appears before the Investigating Officer or the Court whenever required.
9. **Mobile Phone and Contact Details:** Verify that the accused provides active contact details and keeps the mobile phone operational at all times.

10. The Superintendent of Police (ARS): Shall supervise and ensure that the accused does not establish any contact with associates or co-accused.

11. Documentation and Reporting: Record all compliance checks, violations, or suspicious activities and promptly report any breach of bail conditions to the Court for appropriate action, including preparation of a report for cancellation of bail.

Also directed that the above mentioned instructions are to be strictly adhered and complied. Any deviations/non-compliance shall be viewed seriously.
