
In order to promote awareness regarding importance of updation of latest contact details in PRAN, the following activities will be undertaken during NPS Service Week.

1. Distribution of Subscriber Brochure for Govt. subscribers (May be downloaded from DAT website (<http://dat.puducherry.gov.in>))
2. Updation of subscriber details through official letter/S2 form (Inclusion of Bank details, Passport number, Nominee details, Aadhaar number, Voter ID, Mobile No., Email ID etc.) The list of subscribers along with PRAN number for whom Bank details, nominee details, mobile number and Email id are found to be missing in the CRA system are provided in the DAT website (<http://dat.puducherry.gov.in>) for necessary action.
3. Conversion of NON-IRA to IRA (Subscribers who are not having prankit are considered as NON-IRA and will not have the right to claim withdrawal request under National Pension System). The list of Non-IRA compliant is provided in the DAT website for necessary action.
4. Printing of Transaction Statement on request of the subscriber
