C I R C U L A R

It has been brought to the notice of the undersigned that the proposals seeking sanction of the competent authority for filing of appeal against the acquittal orders of trial courts are not submitted in statutory time limit.

2. The time factor is of utmost importance particularly where appeals have to be filed or an order is required to be passed to stay the operation of the order issued by a court or seek its revision etc.

3. It is, therefore, of utmost importance that all matters pertaining to courts, particularly where action is required to be taken by the department in terms of filing of a reply or filing of an appeal etc. the files should be moved with utmost care and vigil to avoid any delay. Sending files in a routine manner and following lengthy bureaucratic procedures should be avoided. The dealing hand as well as officer in charge and the District/Unit in charge shall be held responsible for any delay. Likewise, in the Police Headquarters, there should be no delay whatsoever in obtaining the approval/orders of the officers concerned.

4. Therefore, all SDPOs / CIs / Inspectors / SHOs concerned should examine all such cases which ends in acquittal for filing an appeal and pursue their files at various levels and to ensure that the file reaches the competent authority in time.

5. All the Investigating Officers should also maintain close co-ordination with the Public Prosecutor for obtaining the opinion on filing an appeal for cancellation of bail and also for scrutinizing the acquittal cases for filing of appeal in fit cases.

6. SSSP should closely monitor this periodically and ensure scrupulous compliance of the above instructions.
