MEMORANDUM

Sub: DM, Puducherry – General Election for the Puducherry Legislative Assembly-2016 – Suspension of Licence issued under Explosive Act and Rules – Orders – Issued.

In order to ensure free and fair election and to prevent any possible misuse of explosive and ammunition by the units engaged in the manufacture and storage of Arms and ammunitions materials in the Puducherry District and to ensure the security of the public peace and public safety during the election process, in exercise of the power conferred under section 6E of the Explosives Act- 1884, the District Magistrate, Pondicherry hereby suspend the licenses of all cracker manufacturers issued in Form – LE-3 and Licenses issued to possess and sell, fireworks issued in Form – LE-5 with immediate effect in respect of entire Puducherry District. The Licensees may be directed under Section 6E(9) of the said Act to surrender the Licenses to the Sub-Divisional Magistrates concerned.

The Executive Magistrate – cum- Tahsildars /Deputy Tahsildars of Taluk/Sub-Taluk office are hereby directed to inspect the premises of all such licence holders in respect of Fireworks/Crackers manufactures, verify the stock position and ensure that the stock available with the manufacturer or the seller is kept in their licensed place itself after taking all safety precautionary measures. The place shall be got sealed accordingly and material shall be released only upon the written orders from the District Magistrate.

In addition to the above, the Executive Magistrates are also directed to inspect the premises of erstwhile licence holders and unlicensed premises if any in respect of which credible information has been received about the possession or storage or use of explosive etc.,

The Order should be strictly adhered to and compliance report shall be submitted within 48 hours.
