MINUTES OF THE MEETING HELD IN THE CHAMBER OF SUB-COLLECTOR (REVENUE) NORTH ON 16.09.2011 AT 04.30 P.M. IN CONNECTION WITH DISCUSSION OF REMOVAL OF DEFACEMENTS

The following officials attended the meeting and discussed the following issues:

- (2) The Supdt. Of Police (South)
- (3) The Executive Engineer, B & R (Central), PWD, Pdy.
- (4) The Executive Engineer, Oulgaret Municipality
- (5) The Executive Engineer, Ariankuppam, Municipality
- (6) The Revenue Officer, O/o. SCR (N), Puducherry.



1. At the outset, the Sub Collector has stated that the Model Code of Conduct has come into force with effect from 06.09.2011 consequent to the announcement of bye-election to the Indira Nagar Constituency and directed all the officials to remove all the defacements immediately which includes digital banners, posters, wall paintings and other disfigurements unauthorized structures which may violate the Model code of Conduct.
2. The SP(South) representing the Police Department has been directed to give co-operation to the Commissioners of Local Bodies and PWD at the time of removal of defacements to ensure security and safety for the staff removing defacements.
3. All officials have been directed to remove all the defacements on or before 20.09.2011 and legal action may be initiated against those who violate the Model Code of Conduct by erecting banners.
4. It was directed to give wide publicity in the local TV Channels and media to create awareness of the public to not to erect any banners/cut-outs.
5. It was suggested that An All party Meeting has to be conducted in order to solicit their co-operation at the time of removal of defacements and also not to erect banners / cut-outs which will deface the town not only at the time of elections but also in all the days to come.
6. Finally, the Sub-Collector reiterated that Municipalities & PWD being the Nodal Department for removal of defacements and they are responsible for the removal of defacements by ensuring that no any defacement is found any where after 20.09.2011. in their respective jurisdictions. The police may be intimated prior to the removal of the defacement.
