The National Disaster Management Authority is implementing “Up-scaling of Aapda Mitra” in order to improve local capacity in Disaster response across India. The Scheme is focused on training 1.00 lakh community volunteers in Disaster response in 350 highly vulnerable Districts prone to Flood, Land Slide, Cyclone and Earthquakes. This UT of Puducherry included under the scheme and 500 Volunteers have to be trained. In this regard a copy of the letter cited 1st under reference is enclosed all along with the Memorandum of Understanding entered by this administration for ready reference. Further it is informed that the National Disaster Management Authority (NDMA) is providing fund and the scheme inter alia requires to designated State Level Training Institute for implementation of the said scheme.

Accordingly with approval of the Hon’ble Lt. Governor, the Fire Services Department has been designated as “State Training Institute – Aapda Mitra” for implementation of “Up-scaling of Aapda Mitra” scheme vide reference cited 2nd above. The State Authority, District Authorities in co-ordination with ESFs / Line Departments will be providing all logistic support for the successful implementation of the said scheme.

In this regard, the Divisional Fire Officer, Puducherry shall initiate necessary action at their end under intimation to this Authority.
