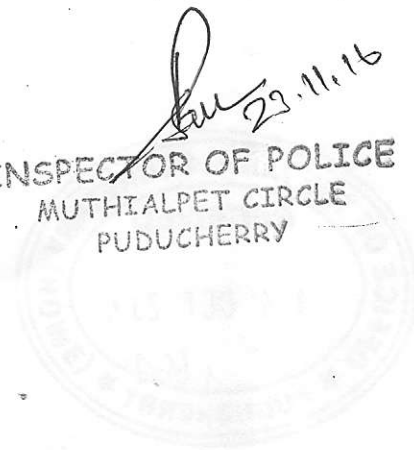

An Indian Origin French citizen of Puducherry met HLG and expressed his grievance in the Open House, regarding burglary of his house in which the burglars had also dismantled the CCTV camera and equipments.

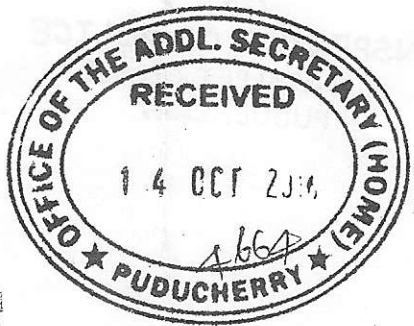
Hon'ble Lt. Governor has observed that an advisory note needs to be circulated on the preventive measures that need to be taken by the French citizens hailing from Puducherry.

Hon'ble Lt. Governor has desired that the French citizens may be advised that whenever they are proceeding away from Station should intimate the duration of their stay away to the Beat Officer concerned. CCTV camera equipments have to be fixed externally to avoid tampering. Invariably, all French citizens should be advised to take Insurance Cover of household articles and valuables.

Therefore, Home Department may kindly be instructed to issue the advisory to the French Consul General to communicate to the Indian origin French citizens who have properties in Puducherry.
