ORDER:

The following Notification shall be published in the next issue of the extraordinary official Gazette dated 26.07.2013:-

NOTIFICATION

WHEREAS orders were issued in pursuance of sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), directing that the District Magistrate, Puducherry and Karaikal may also, if satisfied as provided in sub-section (2) of the said section, exercise the powers conferred by the said sub-section for a period of three months from 28th April, 2013 in the Home Department's Notification issued in G.O.Ms.No.21 dated 10th April, 2013;

2. AND WHEREAS the Lieutenant-Governor, Puducherry having regard to the circumstances prevailing in the Union Territory of Puducherry is satisfied that it is necessary to extend the said period by three months from 28th July, 2013;

3. NOW, THEREFORE, in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), the Lieutenant Governor, Puducherry hereby extends the powers conferred the said sub-section for a further period of 3 months from 28th July, 2013.
