NOTIFICATION

In exercise of the powers conferred under sub-section(1) of section 501 of the Puducherry Municipalities Act, 1973 readwith the rule 5 of the Puducherry Municipalities [Prevention of Infection and Control of Corona Virus Disease (COVID-19)] (Amendment) Rules, 2020 and in partial modification of the Notification issued vide G.O. read above, the Lieutenant-Governor, Puducherry hereby authorizes the officials in the rank of Sanitary Maistry Grade-II and above in the Municipalities, rank of Village Administrative Officer and above in the Department of Revenue and Disaster Management, Constables (who are graduates)

and above rank officers in the Police Department, General Duty Medical Officer and above rank officers in the Department of Health and Family Welfare Services and Assistant Inspector of Factories, Assistant Inspector of Labour and above rank officers in the Labour Department to impose and collect the fine as prescribed in the Puducherry Municipalities [Prevention of Infection and Control of Corona Virus Disease (COVID-19)] Rules, 2020 upon the violators of the containment measures specified in the aforesaid rules.
