Home Department - Re-organization of Sub Divisions in Puducherry and in Karaikal districts of Union Territory of Puducherry and declaration of Inspector of Police as Station House Officer in some of the Police Stations - Orders - Issued.

ORDER

The following Notification shall be published in the Official Gazette of Government of Puducherry.

NOTIFICATION

WHEREAS, the Police Department has stated that the existing sub-divisions of Puducherry are not territorially contiguous and some of them are now spread over large areas which affect the mobility of the officers/force and also administratively inconvenient to handle critical law and order issues and population in the outlying areas has increased manifold for the last ten years and several new residential colonies and commercial centres have come up in these areas;

2. AND WHEREAS the crime rate in these areas are also gone up which require close monitoring and effective administrative control by the supervisory officers and this necessitates re-organisation of present three Sub Divisions of Puducherry Region into four Sub-Divisions as, North, East, West and South and the Karaikal District is proposed to be Sub divided into two Sub-Divisions to be headed by SP Karaikal (North) and SP Karaikal (South) for better Administrative Control;

3. AND WHEREAS, some of the Police Stations have become more complex than others and it is felt that a senior Officer in the rank of Inspector may exercise better supervision as Station House Officer and therefore, the Police Department has proposed that, some of the Police Stations may be placed directly under the control of Inspectors instead of Sub-Inspector of Police as Station House Officer and the remaining Police Stations under the control of Sub-Inspector of Police as Station House Officer;

4. NOW, THEREFORE, in supersession of the order issued in G.O.Ms.No. 63, dated 28<sup>th</sup> December, 2003 of the Home Department, Government of Puducherry and published in Part I of the Extraordinary official Gazette No.145, dated 31<sup>st</sup> December, 2003, save as respect of things done or omitted to be done before such supersession, the

**1. PUDUCHERRY REGION:**

**I. NORTH SUB-DIVISION UNDER THE CONTROL OF THE SUPERINTENDENT OF POLICE (NORTH)**

- (i) Lawspet Police Station - Inspector of Police as Station House Officer
- (ii) **D'Nagar Circle - headed by Inspector of Police**
  - (a) D'Nagar Police Station - Sub-Inspector of Police as Station House Officer
  - (b) Sedarapet Police Station - Sub-Inspector of Police as Station House Officer

**II. Mettupalayam Circle - headed by Inspector of Police**

- (a) Mettupalayam Police Station - Sub-Inspector of Police as Station House Officer
- (b) Reddiyarpalayam Police Station - Sub-Inspector of Police as Station House Officer

The Office of the Superintendent of Police (North) shall be located at Mettupalayam Police Station Complex.

**II. EAST SUB DIVISION UNDER THE CONTROL OF THE SUPERINTENDENT OF POLICE (EAST)**

**(i) Muthialpet Circle - headed by Inspector of Police**

- (a) Muthialpet Police Station - Sub-Inspector of Police as Station House Officer
- (b) Kalapet Police Station - Sub-Inspector of Police as Station House Officer
- (ii) Grand Bazaar Police Station - Inspector of Police as Station House Officer
- (iii) Odhiansalai Police Station - Inspector of Police as Station House Officer
- (iv) Orleanpet Police Station - Inspector of Police as Station House Officer

The Office of the Superintendent of Police (East) shall be located at the present Office of the Superintendent of Police (North)

**III. WEST SUB-DIVISION UNDER THE CONTROL OF THE SUPERINTENDENT OF POLICE (WEST)**

**(i) Nettapakkam Circle - headed by Inspector of Police**

- (a) Nettapakkam Police Station - Sub-Inspector of Police as Station House Officer.
- (b) Thirubhuvbanai, Police Station - Sub-Inspector of Police as Station House Officer.
