The following Notification shall be published in the Official Gazette of Government of Puducherry.

NOTIFICATION

WHEREAS, in Puducherry Region, Traffic Police Station (North), Traffic Police Station (South) and Traffic Police Station (Rural) are functioning at Jawaharlal Nehru Street, Puducherry, at No.4, Navasannathi Street, Villianur, Puducherry and at Kirumampakkam Police Station Complex, respectively under the supervision and control of the Superintendent of Police (Traffic), Puducherry with the extent of jurisdiction as specified in the G.O. Ms. No.70, dated 17.11.2011 of Home Department, Government of Puducherry and the Traffic Police Station, Karaikal functioning at Karaikal Town, Traffic Police Station, vide Notification No.63-41/61-Home,dated 26.09.1967.

AND WHEREAS, it has been decided to divide entire Traffic Unit controlled by Superintendent of Police (Traffic) into two Superintendents of Police i.e Superintendent of Police (Traffic-North-East) and Superintendent of Police (Traffic-South-West) and rename the entire Traffic Unit Puducherry Region as Traffic Police Station (North), Traffic Police Station (East), Traffic Police Station (South) and Traffic Police Station (West) for effective control and management of Traffic in the Puducherry Region and divide the Traffic Police Station Town, Karaikal as Traffic Police Station Town and Traffic Police Station T.R.Pattinam under the control of one Inspector of Police (Traffic), Karaikal.

NOW THEREFORE, in supersession of the order issued in G.O.Ms.No. 70, dated 17th November, 2011 of the Home Department, Government of Puducherry and Notification No.63-41/61-Home,dated 26.09.1967, save as respect of things done or omitted to be done before such supersession and in pursuance of clause(s) section 2 of the Code of Criminal Procedure, 1973(Central Act 2 of 1974), the Lieutenant - Governor, Puducherry is pleased to declare the Traffic Police Stations mentioned at column(2) of the Table shall be the Traffic Police Station and to re-organize the Traffic Police Unit of Puducherry Police, as detailed below:-


