The following Notification shall be published in the extraordinary issue of the Official Gazette of Puducherry :-

NOTIFICATION

In exercise of the powers conferred under sub-section (1) of Section 64 of the Bharatiya Nagarik Suraksha Sanhita, 2023, read with Notification vide SO No.2506(E) dated 28.06.2024 of the Ministry of Home Affairs, Government of India, New Delhi, the Lieutenant–Governor, hereby notifies that every Police Station shall maintain a Register for entering the following details in respect of every person to whom summons by the Courts are issued, either through physical mode or electronic communication based service, in the following manner:-

1. Name of the Court and Designation by whom the summon is issued;
2. Full name of the person summoned;
3. Name of father/mother/spouse of the person summoned;
4. Present address and permanent address of the person summoned, if any;
5. Mobile number (or any other telephone fax number / e-mail id) over which summon is being dectronically served through various communication application(s);
6. Email address of the person summoned;
7. Name of District, where the person summoned is currently residing;
8. Name of the Police Station, where the person summoned is currently residing, specifying the following details:-
 - (a) First Information Report Number;
 - (b) Case Registration date;
 - (c) Offences (under section);
 - (d) Police Station; and
9. Case Number Record (CNR Number) if any.
