NOTIFICATION

In exercise of the powers conferred under sub-section (2) of Section 497 of the Bharatiya Nagarik Suraksha Sanhita, 2023 read with Notification vide SO No.2506(E) dated 28.06.2024 of the Ministry of Home Affairs, Government of India, New Delhi, the Lieutenant-Governor, Puducherry, hereby declares that the description of the property as mentioned in sub-sections (1) and (2) of Section 497 of the Bharatiya Nagarik Suraksha Sanhita, 2023, shall be prepared in the format as under:-

1. Name of property.
2. Quantity/ description and Number of property/article of property.
3. Whether the property is perishable or not.
4. The FIR No.-----dated ---- under Section----- Police Station.
5. Whether the property is produced before the Court during trial and exhibited in evidence.
6. Whether the photographs/videography of the property/article are taken.
7. Whether the properties/articles are claimed by any claimant.
8. The release/disposal of the property/article to the claimant with details of surety taking indemnity bonds.
