Whereas sanction of the Lieutenant Governor was conveyed for incurring of an expenditure not exceeding Rs.1,06,75,300/- (Rupees one crore six lakhs seventy five thousand and three hundred only) towards the Modernization of Police Control Room by installing Dial 100, CCTV and Vehicle Tracking System from M/s Interchain Solutions Ltd., Bangalouru who have quoted the lowest rate vide reference second cited.

2. Whereas as per the above Government Order 40% of the above amount was already paid to M/s Interchain Solutions Private Limited, Bangalore vide D.D. No.281774 dated 07.10.2010.

3. Where as, M/s Harman International India Private Limited, Bangalore had acquired M/s Interchain Solutions Private Limited, Bangalore from 01.09.2012 vide Form No.23 and approval of SRN B56581549 dated 31.08.2012. They have also supplied all the materials and installation is nearing completion.


