2. The grant of financial up-gradation under MACP Scheme shall be governed by the following terms: -

- a) The Employee shall have the option which is to be exercised within one month from the date of issue of up-gradation order under MACP scheme to get his pay fixed under the provisions of FR 22(I) (a) (1). In case of failure to exercise his option within the prescribed time limit, the pay will be fixed as per rules in force by the concerned section.
- b) No stepping up of pay would be admissible with regard to junior getting more pay than senior on account of pay fixation under the MACP Scheme.
- c) He will not be any further fixation on functional promotion following the financial up-gradation.
- d) If he refuse to accept the regular promotion and agree to accept the promotion on later date, his subsequent Financial Up-gradation will get postponed.
