2. The Advisory Board has recommended for the premature release of the above said life convict prisoners.

3. The above premature release is subject to the following conditions:-

- (i) The above life convict prisoners shall report to the Station House Officer of the respective Police Stations on first day of every month.
- (ii) The above life convict prisoners shall be under supervision of Station House Officer of the respective Police Stations.
- (iii) They should not associate with bad characters or lead a dissolute life. They should be of good behaviour and should not commit any offence. They should ordinarily reside in the respective Police Station limits and shall not leave the area without permission from the Station House Officer.

4. They are ordered to be set free forthwith subject to strict observance of the conditions stipulated.
