

On the recommendation of the PEB held on 28.03.2016, Thiru. Sasikumar Nair, Retired SI (PPO. No. 26335) is granted 3<sup>rd</sup> financial upgradation under the MACP Scheme, in the Grade Pay of Rs. 4200 in PB-2 : Rs. 9300-34800 on completion of 30 years of regular service as detailed in the Annexure.

2. The grant of financial upgradation under MACP Scheme shall be governed by the following terms :-

- a) He is entitled to exercise option to get his pay fixed in the next higher scale based on the date of increment in the present scale of pay, as per rules in force.
- b) No stepping up of pay in the Pay Band or Grade Pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme.
- c) There will not be any further fixation on functional promotion following the financial up-gradation.


