Consequently the Judicial Magistrates I, II and III are hereby directed to transfer all FIRs and the pending cases duly indexed along with Case Properties to the respective Judicial Magistrate as mentioned above.

Further, the Judicial Magistrates I, II and III, Puducherry are required to transfer all the private complaints pertaining to the above Police Station limits, after duly indexed, to the Court of the Judicial Magistrate-IV, Puducherry.

All the Superintendent of Police are required to give instructions to their subordinates to follow these instructions strictly in filing the FIR's and Charge Sheets and sending the Case Properties seized to the respective Courts and to extend their full co-operation.

This proceeding shall take effect from the forenoon of 12th December, 2015.
