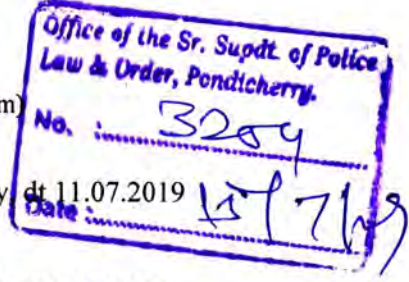

STANDING ORDER

With vide reference cited to the subject mentioned above, the Principal Magistrate, Juvenile Justice Board, is hereby pleased to delegate the duties and responsibility to the Members of Juvenile Justice Board, Puducherry as mandated under Rule 6 (8) of Pondicherry Juvenile Justice (Care and Protection of Children) Rules 2017 as follows.

“Rule 6 (8) When the Board is not sitting, a child in conflict with law may be produced before an individual member of the Board. For the said purpose, one member of the Board shall always be available or accessible to take cognizance of any matter of emergency and necessary directions required to deal with the emergency situation shall be given by such member to the Special Juvenile Police Unit or the local police of the district. The Principal Magistrate shall draw up a monthly duty roster of the members who shall be so available and accessible every day, including on Sundays and holidays. The roster shall be circulated in advance to all the police stations, the Chief Judicial Magistrate/ Chief Metropolitan Magistrate, the District Judge, the District Magistrate, the Committees, the District Child Protection Unit and the Special Juvenile Police Unit.”

Therefore, the undersigned request the Members of Juvenile Justice Board, Puducherry to make them available and to follow the duties given above scrupulously. Further the Child Welfare Police Officers of each Police Station were instructed to produce the Child in conflict with law only before JJB, Ariyankuppam when the Board is not sitting (i.e, Except on Tuesday and Thursday). Accordingly a monthly duty roster for the Members-JJB is prepared by this Board and annexed along with letter for necessary compliance and perusal.
