

On the recommendation of the PEB held on 19.03.2016, the Police Personnel listed out in the Annexure are granted 1st/2nd financial upgradation under the MACP Scheme, in the next higher grade pay in the hierarchy of recommended revised Pay Bands and Grade pay, as applicable on completion of 10/20 years of regular service respectively, as indicated under column 7 in the annexure against the individual concerned.

2. The grant of financial upgradation under MACP Scheme shall be governed by the following terms :-

- a) they are entitled to exercise option to get their pay fixed in the next higher scale based on the date of increment in the present scale of pay, as per rules in force.
- b) no stepping up of pay in the Pay Band or Grade Pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under the MACP Scheme.
- c) there will not be any further fixation on functional promotion following the financial up-gradation.


