The recommendation of Departmental Screening Committee/ Police Establishment Board held in the month of May 2021 by Circulation Method is hereby conveyed for the grant of First/Third Financial Upgradation under MACP Scheme to 47 Nos. of Police Personnel in the rank of Police Constable/ Head Constable working in Police Department, Union Territory of Puducherry according to their suitability with effect from the dates noted against each as per the Annexure enclosed herewith.

The employees shall have the option to exercise within one month from the date of issue of this financial upgradation Order under MACP Scheme to get their pay fixed under the provisions of FR 22 (1) (a) (i). In case of failure to exercise their option within the prescribed time limit, the pay will be fixed as per rules in force by the respective Establishment Section of Police Department, U.T. of Puducherry and other Units/departments.

They will not be entitled for any further fixation on functional promotion to the higher post.

In the event of denial of regular promotion, their subsequent Financial Upgradation will get postponed.


