

Consequent to the up-gradation of pay scale for the post of Follower (Cook) in Police Department, Puducherry from Rs.2550 – 3200 to Rs.3050 – 4590 in actual basis with effect from 01.01.1996 vide G.O.Ms.No.14 dated 03.03.2016 and on the recommendation of PEB held on 11.08.2016. The approval of PEB is accorded to grant 1st & 2nd financial up-gradation under ACP Scheme and grant 1st, 2nd & 3rd financial up-gradation under MACP Scheme to 18 Nos. of Followers (Cook) working in Police Department, Puducherry according to their suitability with effect from the dates mentioned against their names in the annexure enclosed.

The employees shall have the option which is to be exercised within one month from the date of issue of up-gradation order under ACP/MACP Scheme to get their pay fixed under the provisions of FR 22 (1) (a) (i). In case of failure to exercise their option within the prescribed time limit, the pay will be fixed as per rules in force by the Estt.II(A) Section, O/o DGP, Puducherry.
