Dear Sir,

As you are aware, to mainstream Swachhata across all Ministries and Departments, in April, 2016 the concept of Swachhata Pakhwada was initiated. Under the 2017 Calender of Swachhata Pakhwadas for various Ministries and Departments, the Ministry of Home Affairs will take countrywide initiatives during the period from 1st December to 15th December, 2017. On many occasions, Hon'ble Prime Minister has reiterated that Swachhata Pakhwada should not be treated as a routine fortnight but there should be fifteen days of solid and substantial work on Swachhata. In order to make it a countrywide initiative, rather than being confined to office premises, the following activities may be taken up during Swachhata Pakhwada (1-15 December, 2017) :-

- (i) All CAPFs will take up Swachhata achievements and programmes at the Battalion level during the fortnight.
- (ii) Massive cleanliness drive/mega road cleaning event/Shramdan at important Public Places by the uniform personnel.
- (iii) Display of Swachhata message through banner, posters, and hoardings.
- (iv) Tree Plantation and ensuring maintenance and growth.
- (v) SVP NPA and State PTCs to be the Swachh Bharat Academy/Centres during Pakhwada fortnight.
- (vi) Similarly, Swachhta Pakhwada may be organized at all Police Lines/Barracks and training centers including cleanliness drive/mega road cleaning at importance public places.
- (vii) Police personnel on Traffic duties, may display a simple Swachhata Slogan on back of their uniform.
- (viii) Promotion of Swachh Bharat logo in official documents.

2. It is also requested that DGs may organize a VC/meeting with their field formations for dissemination of information and to review the preparedness, before the Pakhwada begins.

3. We would be grateful if you could organize Swachhata Programmes in all your Battalions/Units/Training Centers during the fortnight from 1st to 15th December, 2017 and launch a massive cleanliness drive/mega road cleaning events etc. and send an action taken report to this Ministry at the earliest. It is also requested that the daily programmes and activities undertaken by your organization may be uploaded on the website of the Ministry of Drinking Water & Sanitation.
