Ref: Beat -II area of Muthialpet PS & Solai Nagar OP area - Reg.

CLG Meeting with the members and representatives from Beat -II area of Muthialpet PS and Solai Nagar OP PS limit was conducted on 17.11.2013 between 1130 and 1500 hrs.


During the meeting, the gathering was briefed on the policing initiatives including the new Beat officer system, CCTNS, Modern Control Room incorporated with CCTV, Vehicle Tracking and Dial 100. They were alerted on the various types of crimes being registered and their modus operandi. Public awareness notice containing of various policing pre-request and Police Officers Phone numbers were circulated. In general all were alerted on various crimes and requested assistance in the prevention of crimes.

The following points / grievance were submitted by them during the meeting.

1. To activate the Automatic Traffic Signal mounted at Ezhaimariamman Koil Junction and Clock Tower Junction and make functional at least during office / school hours.
2. Requested for traffic regulation at Bharathidasan Govt. Girls College and NKC Girls Govt H.Sc school to control traffic congestion
3. Parent's pickup and dropping point shall be fixed at the rear or northern gate of the Bharathidasan Govt. Girls College.
4. Road side Fast food, Road side Kitchen hotels shall be removed. The smoke/smell emerging out of it causes inconvenience.
5. Akkasamy Madam Street and Ambethkar Street runs parallel to MG road linking SVP Salai and Salai street//Perumal koil street Pappammal koil street. Theses roads shall be encouraged to reduce traffic congestion at MG road between SVP salai & Muthialpet Market (Salai street).
6. Platform encroachment at SVP salai to be cleared.
7. Requested to liaise with Puducherry Municipality for the speedy distribution of newly constructed Market at Gingee Salai to its stake holders. If required joint meeting shall be arranged for the stake holders for an amicable settlement to decide the measurement for each shop.
8. School/College buses are not adopted proper boarding points along M.G.Road causing inconvenience.
9. Requested to conduct Police Crime Awareness Programmes in Schools / Colleges periodically to sensitize students on behaviour and dressing codes.
10. Police presence highly requested against Eve teasing. Regular Anti Eve-Teasing Awareness campaign and drives to be conducted.

All were highly convinced on the various discussions held and they expressed their willing and interest to co-operate with Police and other machineries of legal systems to build better secured society.
