2. At the outset, the Chairman-Cum-District Magistrate welcomed the Officers and the observations of the Special Observer were brought to the knowledge of the Officers present and discussions were held on the same. The following action points emerged in the meeting.

i) All the Flying Squads vehicles must be fitted with a wireless set.

Action by: The Superintendent of Police (Traffic -North East)

ii) The Static Surveillance Team must also have a wireless set.

Action by: The Superintendent of Police (Traffic -North East)

iii) The Control room situated at the State Emergency Operation Centre need to be equipped with a wireless set and the same should be manned round-the-clock by an Officer of the Police Department in the rank of Sub-Inspector / Asst. Sub-Inspector.

Action by: The Senior Superintendent of Police (L&O)

iv) SHOs of all Police Stations must be informed for accepting complaints given by various squads on election duty on a priority basis without any delay. The squads must be facilitated while giving any complaints. All SHOs shall be directed to ensure this and render complete cooperation to the squads.

v) The Sub-Divisional Magistrate present brought to the notice of SSP (L&O) that no SHO is attending the SDM Court for the cases brought by them. SSP (L&O) assured that all SHOs shall be suitably instructed to attend the SDM Court and follow up the cases promptly and regularly.


Action by: The Senior Superintendent of Police (L&O)

vi) The Expenditure Observers have observed that the number of Flying Squads functioning in the region are not sufficient. He had directed to provide 3 Flying Squads per Constituency along with 3 Police personnel including one Head Constable / ASI in all the teams. Therefore, sufficient IRBn personnel shall have to be provided to form new Flying Squads.

Action by: The Senior Superintendent of Police (HQ cum Traffic) and The Senior Superintendent of Police (C&I), Puducherry.

3. It was also decided that the Sector Officers available with the Returning Officers shall also frequently go on rounds for enforcing MCC. If any violation is noted by them they can use the services of squads available with the respective Returning Officers. As and when CAPF arrives, Sector Officers will also be given one or two Police personnel for this purpose as per the need assessment.
