

- The study for the course should not interfere with his/her official duties and according to the exigencies of service he/she should make themselves available for duty.
- The permission granted will be withdrawn at any time without assigning any reason thereof in the public interest.
- The permission granted is valid only for particular course during the particular period.
- Mere grant of permission to pursue the course shall not entail the right to claim for promotion etc., which is subject to due procedure followed by the Government.
- Subject to availability of kinds of leave due and admissible duly sanctioned by the Competent Authority.
