Please find enclosed a copy of fax representation received from Shri.Ramdas Athawale, M.P (Rajya Sabha), New Delhi on the subject cited above. On perusal of the representation alongwith its enclosure, it is apparent that the SCs living in SC villages and Reserved Constituencies in U.T of Puducherry are under frequent attack and atrocities are perpetrated by caste Hindus during the election time. The SCs are not given allotment of free houses / plots being distributed through Adi Dravidar Welfare Department. Further, it has been requested that the Puducherry Government may rename PCR Cell into SC/ST Atrocities Cell.

It is, therefore, requested that the above issues may be looked into and appropriate action be taken to protect the SCs n Puducherry. Your reply aongwith action taken may be furnished to this Commission within a fortnight, so as to enable this Office to appraise the same to the Headquarters of NCSC, New Delhi and Shri.Ramdas Athawale, M.P (Rajya Sabha), New Delhi.
