ORDER:

WHEREAS in the G.O. read (i) & (ii) cited, the Protection of Civil Right (PCR) Cell Police Stations were established in the UT of Puducherry under the Scheme "Implementation of Protection of Civil Rights Act, 1955 and the Schedule Caste/Scheduled Tribes (Prevention of Atrocities) Act, 1989".

2. AND WHEREAS, twenty seven (27) no. of Posts were allocated to the PCR Cell Police Stations in various regions of UT of Puducherry, as detailed in Annexure-I and the Pay & Allowances were claimed upto the month of December, 2022 from the CSS funds released by the Ministry of Social Justice and Empowerment, Government of India, under the Head of Account, as detailed in Annexure-II.

3. AND WHEREAS, now the Ministry of Social Justice and Empowerment, Government of India has conveyed, vide read (iii) cited, that as per the EFC recommendations, the component PCR Cell-Police (Home Department) will be borne by the Government of Puducherry (UT with legislation).

4. AND WHEREAS, based on the decision of the Government of India, the Police Department, Puducherry has sought for approval of the Government for creation of new state Head of Account and transfer of 27 posts allocated to PCR Cell, Police Stations and operated under the CSS Head of Account to State Head of Account for payment of salaries from UT's own resource.

5. NOW THEREFORE, sanction of the Lieutenant Governor is hereby conveyed for creation of new Head of Account, as mentioned in Annexure-III, in respect of the PCR Cell Police Stations in the UT of Puducherry and for transferring of 27 various posts (as in Annexure-I) of PCR Cell Police Stations from CSS Head of Account to the newly created State Head of Account. Further, the Pay and Allowances in respect of the 27 posts in the PCR Police Stations shall be claimed from the month of January, 2023 under the newly created Head of Account. Necessary funds are also made available in the respective newly created Heads.

6. This issues with the concurrence of the Finance Department, Puducherry vide their I.D.No: 30147/FC/FD/F5/A3/2023, dated 15-05-2023.
