Sub: PPCC - Implementation of Noise Standards for fire Crackers - Reg.

\*\*\*

I am directed to state that the noise level may be high in the forthcoming Diwali festival season due to bursting of crackers. The Ministry of Environment and Forests, Government of India have notified the noise standards for firecrackers. In this regard, Hon'ble Supreme Court has issued interim direction for strict compliance of the above notification. I, therefore request that as per section 5 of Environment (Protection) Act, 1986, necessary action may be taken to prohibit the manufacture and sale of such crackers generating noise level exceeding 125 dB (A) at 4m distance from the point of bursting as well as implement the other directions of the Hon'ble Supreme Court, i.e. prohibition of the use of fire works or fire crackers between 10.00P.M and 6.00A.M. and total prohibition of fire crackers at any time in silence zone i.e. in an area comprising not less than 100 meters around hospital, religious places, educational institutions, courts buildings etc.

I therefore request that an action taken report may please be sent to the Puducherry Pollution Control Committee on or before 20.11.2012 so as to furnish a consolidated report to the Ministry of Environment and Forests, Government of India.
