

All Superintendent of Police are requested to send the recommendations with soft copy if any, (not more than two cases for each for consideration by the Chief Office along with the Proforma containing particulars for nomination, a brief citation recommending the cases based on factors relating to unblemished records and also a certificate on each individual (as per model copy enclosed).

3. The last date for receiving the nomination with softcopy at the Chief Office is on or before 09.05.2016.
