PRACTICAL TRAINING TO PPS PROBATIONER

Probationer is required to undergo 6 months training soon after completion of basic training and pass out from the PTC. The Probationer shall undergo two weeks indoor classes from 17.08.2017 to 31.08.2017 at Police Training School, Puducherry regarding the following local laws, Standing Orders and Circulars issued by the Department from time to time under the supervision of SSP(HQ), Puducherry:-

- a. Pondicherry Police Amendment Act, 1965.
- b. Pondicherry Sound and Amplifier and Loudspeaker Licensing Rules, 1967.
- c. Pondicherry Gaming Act, 1965.
- d. Pondicherry Home Guards Act, 1965.
- e. Pondicherry Home Guards Rules, 1966.
- f. Pondicherry Police Subordinate Services (Discipline & Appeal) Rules, 1968 with Amendments.

The training schedule is as follows: -

1. 1 Weeks Attachment with SSP (L&O) (01.09.2017 to 07.09.2017)

The Probationary Officer will initially be attached to the SSP (L&O) to acquaint himself with the working of the District and its sub-units, calling on relevant senior officers, study of notes/instructions; understanding the working of different branches of SSP (L&O) Office etc.

2. 15 Weeks Attachment with Police Station (08.09.2017 TO 21.12.2017)

During this period, the probationer will undergo training as under.

1	Police Station Record Branch and CCTNS Project	1 week	Making entries and maintenance of all records, making various diaries/statements sent to the senior officers, working as entry operator of CCTNS Project etc.
2	Case Property/Government Property.	3 days	Making entries in CP/GP registers, upkeep of CPs/GPs, attending courts to see production of case property etc.

4. One Week Attachment with Traffic Police (30.12.2017 to 04.01.2018)

During this period, the probationer officer will acquaint himself with the followings:-

1. Deployment and performance of duties on ground.
2. Challan and Notice system.
3. Functioning of Road Safety Cell.
4. Traffic arrangements on VIP/VVIP Visit.

SP/Traffic (North-East) should ensure that the Probationer does full 3 day duty of a traffic officer at a junction/any other traffic point where he should be suitably guided.

5. 1 week Attachment with SIGMA Security (05.01.2018 to 11.01.2018)

During this period, the Probationer/Officer will acquaint himself with the followings:-

1. Preparation of schemes as per norms & Deployment of Guards, Escorts, PSO, QRTs, etc.
2. Security arrangements for protected persons (PPs).
3. Associate himself with at least 3 different type of VVIP security arrangements.

6. 5 days Attachment with PAP (12.01.18 to 16.01.2018)

During this period, the probationer officer will be attached as follows:-

1. Perform as Company Commander
2. Deployment for Escort, Guard, L&O Bandobust, etc.
3. Function of Armoury, etc.
4. Functions of Office of the Commandant.

7. 3 days Attachment with Director of Prosecution (17.01.2018 to 19.01.2018)

During this period, the probationer officer will acquaint himself with the functioning of the Prosecution Branch pertaining to the district and will learn how the cases are processed within the courts. He will associate himself with the scrutiny of charge sheets, acquittal reports and attendance in courts.

General Instructions

The probationer will be required to maintain a Daily Work Diary and submit the same to the SSP(L&O) concerned for his comments on every Monday. The SSP (L&O) will give his comments on the diary in this regard to classify the nature and quality of training and work put in by the probationer officer and her general behavior and turn out.


The officer will appear with his Daily Work Diary before SSP(HQ) at 11 AM on the first and fifteenth of every month. In case first and fifteenth of any month is holiday, he will appear on the next working day at the same time. He will appear before the DGP on the first working day of each month. It shall be the personal responsibility of the SSP (L&O) to ensure that the probationer is given full attention during him training period.

No leave should be granted during this period and that only under exceptional circumstances, with the prior approval of the DGP.

If the probationer is on leave due to some emergent situations when this phase of training is going on then he should be sent back to the concerned unit for its completion. The training shall not be deemed to be completed till this is done.

After completion of Training, the probationary officer will report to SSP(HQ) for debriefing and will submit a report to DGP.
