AN ACE THIEF ARRESTED: GOLD JEWELLERY & MOTOR-CYCLE,
WORTH Rs. 7.00 LAKH RECOVERED

With the arrest of an accused person, 11 cases of robberies, snatching, burglaries, motor-cycle theft and house theft stand worked out and gold jewellery & motor-cycle, worth Rs. 07.00 Lakh, have been recovered.

On 08.02.17, a case of 'robbery' was registered at Kirumampakkam Police Station on the complaint of Smt. Regina, r/o Tsunami Nagar, Pannithittu, Puducherry. The complainant stated that on the early morning of 08.02.17, an unknown person had snatched her gold Mangalsutra, weighing about 7.0 sov. after assaulting on her head with an iron pipe. On a tip off, SP(South) Abdul Raheem formed a team, led by Inspector Rajasekaran, SI Dhanwantri, SI Chandrasekaran, SI Purushothaman, SI Tamilarasan, SI Thirumurugan and PCs Roman, Thulasi, Anbalagan, Ramadoss of South Sub-Division, to solve the case.

The Police team studied cases with similar modus-operandi and mounted surveillance on known robbers of Puducherry and the neighbouring districts of Tamil Nadu and finally singled-out a suspect, a resident of Pudhukuppam, Puducherry and laid a trap for him. On 10.02.2017, the Police team succeeded in its efforts and nabbed the accused person, viz., Jeeva @ Subramani (34 years), s/o Kathavarayan, r/o Veeran Koil Street, Pudhukuppam, Puducherry. On tactful and sustained interrogation, he confessed to have committing 11 cases, which included the above robbery, 5 cases of snatching (4 cases registered in Thavalakuppam PS and 1 case in Ariyankuppam PS), 1 case of burglary (Thavalakuppam PS), 1 case of hundial theft (Kirumampakkam PS), 1 case of house theft (Ariyankuppam PS), 1 case of Motor-cycle theft (Kirumampakkam PS) and 1 case of attempt to commit theft of copper wire from the Electricity Sub-Station, Mullodai, Kirumampakkam.

The confession led to the recovery of 20 sovereign of Gold Jewellery and one Motor-cycle, worth Rs. 07.00 Lakh. The accused person Jeeva @ Subramani is already involved in cases of murder, hurt and eve-teasing.
