PRESS RELEASE

As per para 8(a) of Election Commission of India's instructions contained in its Letter No.3/7/2008/JS-II dated 07.10.2008 display of flag and stickers in private vehicles is allowed subject to the provisions of Motor Vehicles Act and Rules thereunder and court orders in force. The flag and stickers should be displayed in such a manner that they do not cause any inconvenience or distraction to other road users. However, if such display of flags and stickers solicits vote for any particular candidate then the provisions of section 171(H) of IPC would have to be strictly followed. Further, the Commission has stated that the Notification No.1401/DM/RO/D2/GEHP/2016 dated 04.03.2016 invoking section 4 of Puducherry Open Places (Prevention of Disfigurement) Act, 2000 issued by Government of Puducherry is in consonance with its instructions. Therefore, small flags and stickers not attracting provisions of Motor Vehicle Act and also not having any slogan etc., may be displayed if put on own volition of the owner and no permission is required from the Chief Electoral Officer/Returning Officer.
