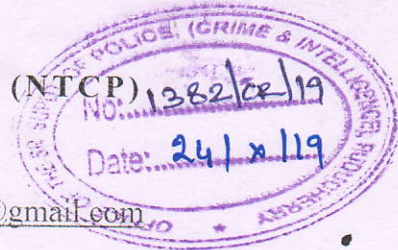

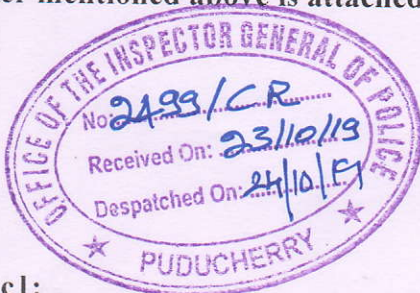
Sub: Prohibition of Electronic Cigarettes (production, manufacture, import, export, transport, sale, distribution, storage and advertisement) Ordinance, 2019 –Reg

Ref: No.24013/50/Misc/2019-CSR.III dated 07-10-2019 from Shri.S.K.Shahi, Joint Secretary to Govt. of India, Ministry of Home Affairs (CS Division), GOI.

With reference to letter cited above, I am to inform that, Electronic Cigarettes which includes all forms of Electronic Nicotine Delivery Systems, Heat Not Burn Products, e-Hookah and the like devices are prohibited through 'The prohibition of Electronic Cigarettes (production, manufacture, import, export, transport, sale, distribution, storage and advertisement) Ordinance, 2019' by Govt. of India with effect on 18.09.2019. In addition to this a G.O. was passed in Puducherry UT to Ban on sale (including online sale), manufacture, distribution, trade, import, advertisement, display, marketing and possession of Electronic Nicotine Delivery System (ENDS) including e-Cigarettes, Heat- not- Burn devices, Vape, e-Sheesha, e-Nicotine flavoured Hookah and the like devices, its parts and components in any shape or size of cartridge containing nicotine vide G.O. Ms. No.5 dated 23.01.2019.

In this regard, it is requested to take necessary actions to implement the ordinance in Puducherry UT in the larger interest of Public Health. The State Tobacco Control Cell is happy to extend any technical support in this regard. **Further, it is requested to circulate the Ordinance amongst all concerned officers in your department for taking necessary action. The copy of the ordinance along with the letter mentioned above is attached for your kind perusal.**
