2. They will draw Pay in the Pay Matrix **Level 5** plus usual allowances as admissible under rules in force from time to time. Their pay and allowances shall be claimed against the existing vacancy in the Police Department, Puducherry.

5. The Police Officers posted in the outlying regions shall report over phone to the concerned place of duty. The respective Officers shall send the joining & relieving reports simultaneously over mail (followed by hard-copies) to the concerned Officers for claiming their pay & allowances.
