**MEMORANDUM**

Sub: Police – Grant of regular promotion to the post of Inspector of Police –  
Orders – Issued.

As per the directions of the Home Department, Puducherry vide O.M. No.C-4349/2018/Home/P1 dated 28.11.2018 and in compliance of the Order of Hon'ble CAT, Madras Bench in MA/310/00919/2017 (in) (&) OA/310/00362/2017 dated 07.02.2019 to revise the seniority issued in the post of Sub-Inspector of Police vide Order first cited, tentative seniority was issued vide Memoranda second cited. Thereafter, consequent to the directions of the Home Department, Puducherry vide O.M. No.A.6078/SI-Snty/Home/P1/2019/ dated 10.01.2020 based on the judgment of the Hon'ble Supreme Court in the case of Shri. K. Megachandra Singh & Others Vs. Ningam Siro & Others a revised tentative seniority was issued in the post of Sub-Inspector of Police by inviting objections vide Memorandum third cited. However, by taking into account the objections received based on the tentative seniority circulated vide Memoranda second cited, seniority was revised and issued vide Order fourth cited.

2 Thereafter, based on the O.M. No.20011/2/2014-Estt(D) dated 13.08.2021 of the DoPT which was communicated by the DP&AR vide I.D.Note/OM No.23019/2016/DP&AR/CCD(2) dated 23.08.2021, the final seniority issued vide Order fourth cited was revised and Final seniority was issued vide Memorandum fifth cited by taking into account the objections received based on the tentative seniority issued vide Memorandum third cited.

3. In the meanwhile, the PEB held on 14.11.2014, 26.11.2014, 10.12.2014, 25.01.2016, 12.06.2017 and 20.11.2018 has considered and recommended for grant of ad-hoc promotions to the post of Inspector of Police on the basis of the seniority issued vide Order first cited in the post of Sub-Inspector of Police. As the seniority issued vide Order first cited has been revised and final seniority has been issued vide Memorandum fifth cited, it has become mandatory to review the above PEBs on the basis of the final seniority issued vide Memorandum fifth cited.

4. Accordingly, as per the recommendations of the review PEB held on 18.07.2022 the following Sub-Inspectors of Police are notionally promoted to the post of Inspector of Police on regular basis with effect from the date mentioned against them, with monitory benefit from the actual date of joining the post of Inspector of Police. If the



earlier appointment in the post of Inspector of Police on ad-hoc basis were to be before the date of regular promotion, their appointment in the post of Inspector of Police will have to be taken into account only from the date of joining the post on regular basis.

5. The incumbents mentioned at Sl.No.1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, 19, 20, 21, 24, 25 and 41 are already officiating in the post of Inspector of Police and the incumbents mentioned at Sl. No. 27, 28, 29, 32, 34, 35, 36, 37, 38, 40 & 43 are holding the post of Inspector of Police on CDC. Hence, no posting order is required to them now. In respect of the incumbents mentioned at Sl. No.22, 26, 31, 39 & 42 posting order will be issued separately.
6. Further, as per the recommendations of the PEB Tmt. S. Janagi, Sub-Inspector of Police is promoted to the post of Inspector of Police on regular basis with immediate effect. The posting order will be issued to her separately.
7. Apart from the above, as per the recommendations of the PEB, Thiru V. Purushothaman holding the post of Inspector of Police on CDC is promoted to the post of Inspector of Police on regular basis with effect from 01.08.2022.
8. The above officials will draw their pay at Level-7 in the Pay Matrix (Pre-revised PB-2 Rs.9300-34800+GP:4600) plus usual allowances admissible from time to time.
9. If the above officials have already been granted financial up-gradation under the ACP/MACP scheme, they will not be entitled for any pay fixation on this promotion.
10. The promotion order issued to the above incumbents is subject to the outcome of the Review Petition No.170 of 2019 in W.P. 7903 of 2008 filed in Hon'ble High Court, Chennai and OA 248/2020, OA 116/2021, OA 117/2021 and OA 769/2021 filed in Hon'ble CAT, Madras Bench.
