ORDER

Sub: Home (Police) - Promotion of Inspector of Police as Superintendent of Police - Orders - Issued.

The Lieutenant-Governor, Puducherry, is pleased to order the promotion of Thiru V.T. Abdul Raheem, Inspector of Police as Superintendent of Police in the Pay Band PB.2 (Rs.9, 300 - 34,800) with Grade Pay of Rs.4, 800 on purely temporary and adhoc basis retrospectively with effect from 01.08.2009 and posted as Superintendent of Police (Home Guards). However, Thiru V.T. Abdul Raheem, Superintendent of Police (Home Guards) is eligible for monetary benefit with effect from the date of actual assumption of duty in the promoted post.

02. The above adhoc appointment will not bestow on the officer a claim for regular appointment. The services rendered on adhoc basis in the grade would also not count for the purpose of seniority in that grade and for eligibility for promotion to next higher grade.
