MEMORANDUM


Sub: Police – Estt.I(A) – Promotion to the post of Inspector of Police on ad-hoc basis – Orders – Issued.

Thiru. R. Shanmugam, Inspector of Police was promoted to the post of Inspector of Police in the PEB held 25.01.2016. Now in the review PEB held on 18.07.2022 has recommended to promote him on ad-hoc basis w.e.f. 12.06.2017. As he is already holding the post of Inspector of Police on ad-hoc basis, he will continue to hold the post on ad-hoc basis with the following conditions.

- i) The promotion is being made “on purely Ad-hoc basis” and the ad-hoc promotion will not confer any right for regular promotion; and
 - ii) The promotion shall be “until further orders”. The Department reserves the right to cancel the ad-hoc promotion and revert, at any time, the Government servant to the post of from which he was promoted.
2. He will draw pay in the Pay Level –7 of the Pay Matrix (Pre-revised Pay Scale PB-2: Rs.9,300-34,800 + G.P.Rs.4600/-).
 3. If the above individual has already got financial up-gradation under ACP/MACP Scheme, he will not be entitled to any pay fixation on this promotion.
 4. The promotion order issued to the above incumbent is subject to the outcome of the Review Petition No.170 of 2019 in W.P. 7903 of 2008 filed in Hon’ble High Court, Chennai and OA 248/2020, OA 116/2021, OA 117/2021 and OA 769/2021 filed in Hon’ble CAT, Madras Bench.
 5. Posting Order will be issued separately.
