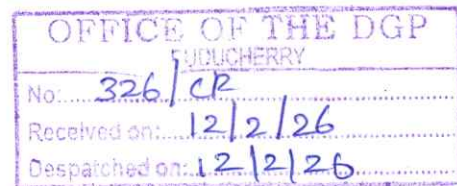

MEMORANDUM

Sub.: Home (Police) - Promotion of Sub-Inspectors of Police to the post of Inspector of Police - Orders - Issued.

The Police Establishment Board in its meeting held on 23.07.2010 had considered promotion of Sub-Inspectors of Police to the post of Inspector of Police in the Police Department, Puducherry. However, subsequently it was noticed that the Police Establishment Board is empowered to decide on service related matters of Police personnel, except those which are covered by statutory rules like the Recruitment Rules framed under Article 309 of the Constitution of India.

2. Hence, only the Departmental Promotion Committee specified in the relevant Recruitment Rules is empowered to recommend promotion to the post of Inspector of Police in the Police Department, Puducherry, which then requires approval of the Appointing Authority.

3. Further, the Enforcement Cell, Puducherry opined that the Post-based Reservation Roster pertaining to the PEB meeting held on 23.07.2010 had to be revisited by the Police Department and observed that 3 SC vacancies should have been considered in the said PEB meeting. In order to review the PEB meeting held on 23.07.2010, it was necessary to review the PEB meeting held on 07.07.2009 and also to revisit the relevant Post-based Reservation Roster by the Police Department. Therefore, the earlier promotions to the post of Inspector of Police recommended by the PEB meetings held on 07.07.2009 and 23.07.2010 have been reviewed by the PEB on 05.01.2026. The said recommendations of the PEB have been affirmed by the duly constituted DPC in its meeting held on 20.01.2026 and was submitted to the Competent Authority viz. the Hon'ble Lieutenant Governor for necessary ratification.

4. Accordingly, the Competent Authority has been pleased to ratify and approve the promotion of the Sub-Inspectors of Police to the post of Inspector of Police on regular basis, based on the recommendations of the Departmental Promotion Committee held on 20.01.2026, which affirms the recommendations of the review PEB meeting held on 05.01.2026 reviewing the promotions granted by PEB meetings held on 07.07.2009 and 23.07.2010. Accordingly, the select lists of the candidates finalised by the PEB in its meetings held on 07.07.2009 and 23.07.2010 stand modified as detailed in the annexure.

5. They will draw pay in Pay Band 2: Rs.9300-34800 + Grade Pay Rs.4600 plus other allowances as admissible under rules in force from time to time.

6. The pay of the officials shall be fixed under the provisions of FR 22(I)(a)(1). If the officials have already been granted financial upgradation under ACP/MACP, no further pay fixation is eligible/admissible.

7. The promotion of Thiru K. Dhanasekaran and Thiru B. Danassegaran to the post of Inspector of Police with effect from 23.07.2010 is on notional basis only.


