MEMORANDUM

Sub : Police - Estt.I(A) - Promotion to the post of Sub-Inspector of Police-Orders- Issued.

Ref : Minutes of the Police Establishment Board dated. 27.09.2023

The PEB held on 27.09.2023 has kept the findings of Thiru. G. Archunan, HC 1860 (Seniority No.1175) in sealed cover as a DE initiated against him was pending. On conclusion of the DE, the disciplinary authority has issued the final order as "the proceedings/ allegation leveled against him as **Stands closed**" and also ordered as the **period of suspension** treated as "**Spent on Duty**".

2. Consequent to the above, the sealed cover in respect of Thiru. G. Archunan, HC 1860 was opened in the PEB held on 19.12.2023 by operating the sealed cover procedure and recommended him for promotion to the post of SI of Police on par with his junior.

3. Accordingly, Thiru. G. Archunan, HC 1860 (Seniority No.1175) is promoted to the post of Sub-Inspector of Police under SC category notionally on regular basis w.e.f. 29.09.2023, the date on which his junior Thiru. Z. Pajaniraza, (HC1863 seniority No.1176) was promoted, with monetary benefit from the date of joining the post. Further; his seniority shall be fixed in the post of Sub-Inspector of Police below Thiru. S. Nagarajan, HC 1828 (Seniority No.1172) and above Thiru. Z.Pajaniraza, HC 1863 (Seniority No.1176)

4. He will draw Pay in Level 6 of the Pay Matrix plus usual allowances as admissible under rules in force from time to time.

5. If the above individual has already granted financial up-gradation under ACP/MACP scheme, he will not be entitled for any pay fixation on this Promotion.

6. He should undergo capsule training for 90 days in Police Training School, Puducherry. The Superintendent of Police concerned shall relieve him immediately and report compliance.

7. On relieve, he shall report to the Superintendent of Police (HQ) before proceeding on training.

8. The Posting Order will be issued separately.
