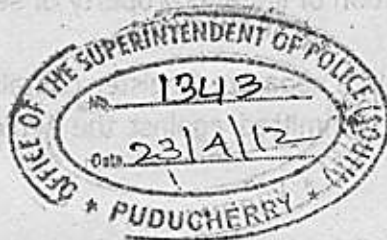

The Govt. of Puducherry has notified 'The Puducherry Maintenance and Welfare of Parents and Senior Citizens Rules, 2011' vide G.O. Ms. No. 32/2011-Wel.(SW-V), dt. 27.10.11. According to the Rule 20 vide Chapter – VI, the Senior Supdt. of Police (L&O) is required to issue an Action Plan for the protection of life and property of senior citizens. As such, an Action Plan is enclosed, which shall be meticulously implemented by all the CIs & SHOs in Puducherry District without fail. The SDPOs concerned shall ensure the same and a compliance report shall be submitted to the undersigned at the earliest without fail.

**ACTION PLAN FOR THE PROTECTION OF LIFE AND  
PROPERTY OF SENIOR CITIZENS**


1. Each Police Station shall maintain an upto-date list of senior citizens living within its jurisdiction with their bio-data, especially those who are living by themselves (i.e.) without there being any member in their household who is not a senior citizen.
2. The Beat Officer of the Police Station together, as far as possible with a social worker or volunteer, shall visit such senior citizens at regular intervals of atleast once a month and shall, in addition visit them as quickly as possible on receipt of a request for assistance from them.
3. Complaints/problems of senior citizens shall be promptly attended to by the local Police.
4. One or more Volunteers' Committee (s) shall be formed for each Police Station which shall ensure regular contact between the senior citizens, especially those living by themselves, on the one hand, and the Police and the district administration on the other.
5. The SHOs shall sensitize the members of the public at regular intervals, the steps being taken for the protection of life and property of senior citizens.
6. Each Police Station shall maintain a separate Register containing all important particulars relating to offences committed against the senior citizens as per Annexure.
7. The Register referred above shall be kept available for inspection and every officer inspecting a Police Station shall invariably review the status as reflected in the Register.
8. The SHOs shall send a monthly report of such crimes to the concerned SDPOs, who shall send a consolidated report to SSP(L&O) by 10<sup>th</sup> of every month.
9. The SHOs shall publicize the list of Do's and Don'ts to be followed by the senior citizens through pamphlets, erection of display boards at prominent places, etc., within their jurisdiction in the interest of their safety.

10. The SHOs shall verify the antecedents of domestic servants and others working for senior citizens on the request of such citizens.

11. The SHOs shall ensure community policing for the security of senior citizens in conjunction with the citizens living in the neighbourhood, Residents' Welfare Associations, Youth Volunteers, Non-Governmental Organisations, etc.

12. The CIs and SDPOs shall bestow their personal attention in ensuring the above action points by their respective SHOs.
